- d) To advise on policy regarding faculty/non-teaching staff, scholarships & freeships, student fees and other matters of common interest concerning NIFTEM and IICPT, and
- e) Any other functions as may be assigned by the Central Government.

(III) The terms & Conditions governing the working of the Council shall be as under:

- a) The Council shall meet once in six months at a venue in India.
- b) The admissibility of TA/DA in respect of official members for attending the meetings shall be governed by the respective service rules applicable in their case and borne by the concerned department to which they belong.
- c) The admissibility of TA/DA, sitting fee, etc. in respect of non-official members shall be equivalent to provisions relating to the entitlement of Joint Secretary to the Government of India.
- d) The term of the official members shall be co-terminus with their tenure in the substantive charge held by them in their parent department/organization.
- e) The term of the representatives of Industry Associations shall be co-terminus with the tenure of the position held by them in the respective Industry Association.
- f) The terms of other non-official members shall be for a period of two years from the date of this order.
