Advertisement Notice

Subject: Engagement of three Consultant having domain expertise in TOP crops for assisting MoFPI in implementation of "Operation Greens" Scheme-reg.

Applications are invited from eligible Candidates for the purpose of selection of suitable personnel for engaging them as Consultants in this Ministry on Contract basis.

i. Eligibility

- a) Retired group 'A' Officers from Central/State Government and their PSUs /Undertakings with minimum 10 year of work experience in implementation of Government Schemes relating to agriculture/horticulture/food processing sector; or

Candidates (*other than retired Govt. Officers*) having Master degree in Agriculture/Horticulture/Food Processing with minimum 10 year of work experience in agriculture/horticulture/food processing sector;

- b) Should possess a good communication skill both oral and written;
- c) Should possess sufficient expertise with regard to production, distribution and value addition of tomato, onion and potato (TOP) crops;
- d) Preference will be given to applicants having experience in integrated value chain management in TOP crops.

ii. Job requirement:

As a new Central sector scheme "Operation Greens" has been rolled out by the Ministry to promote Farmer Producers Organizations (FPOs), agri-logistics, processing facilities and professional management with an allocation of Rs. 500 crore. The consultants will be entrusted with the following roles and responsibilities to assist the Ministry for smooth functioning of official work related "Operation Greens" Scheme;

- a) To provide technical inputs on the TOP crops to the Ministry based on their working experience for effective and timely implementation of the Scheme;
- b) Coordination with other Ministries/Departments/State Govt.;
- c) Monitoring and evaluation of implementation of the projects;

d) Any other work assigned by the Ministry.

iii. **Terms and Conditions:**

- i. The period of engagement as Consultant would be initially for one year with effect from the date of joining as Consultant, which may, at the discretion of the competent authority be either extended or curtailed.
- ii. Consultant (retired group 'A' Govt. officers) will be paid emoluments/remuneration equivalent to "last pay drawn minus the amount of pension being drawn by the selected person". The emoluments and pension drawn should not exceed the last pay drawn by the selected person. In addition, he shall be eligible for local conveyance @ 50% of the transport allowance drawn by him on his last post. However, Dearness allowance shall not be admissible thereon.


Consolidated (other than retired Govt. officers) monthly pay at the rate of Rs. 75,000/- .

- iii. The maximum age for consultant shall be 65 years.
- iv. Service of consultant can be terminated or dispensed with by the Competent Authority at any time without assigning any reasons and without serving any prior notice thereof.
- v. Consultant will be required to maintain decorum, discipline as expected of a regular Central Government employee.
- vi. Working hours shall normally be from 9:00 a.m. to 5:30 p.m. during working days including half an hour lunch break in between. However, in exigencies of work, he may be required to sit late and may be called on Saturday/ Sunday and other Gazetted holidays.
- vii. Consultant shall be eligible for 8 days leave during the period of one year. However, unavailed leave cannot be carried forward, in case of extension beyond one year.
- viii. The Income Tax or any other tax liable to be deducted, as per the prevalent rules will be deducted at source before effecting the payment, for which the Department will issue TDS Certificate/s. Service Tax, as applicable shall be payable extra, at the prevalent rates.
- ix. No other allowance will be payable, however if the Consultant, travels out of the Headquarters he will be entitled to TA/DA as admissible to an officer holding the post in pay matrix 10 of the 7th CPC.
- x. The remuneration would be worked out by applying the following formula:

No. of working days on which office has been attended x Consultancy Fee
No. of working days in the month

*Consultant must possess adequate qualification/work experience in the field of Food Processing sector/Economic sector.
