Minutes of meeting of Inter-Ministerial Approval Committee (IMAC) for the Scheme for Integrated Cold Chain and Value Addition Infrastructure held on 11.12.2019

A meeting of Inter-Ministerial Approval Committee (IMAC) constituted under Scheme for Integrated Cold Chain and Value Addition Infrastructure was held on 11.12.2019 under the Chairpersonship of Minister, FPI.

2. The list of participants is at **Annexure-I** and **Annexure-II**.

3. At the outset, Joint Secretary and Convener of IMAC welcomed the Minister, FPI and other members of the Committee. The IMAC was informed that 5 cold chain proposals being considered now have been reviewed by Committee of Independent Monitors (CIM) based on the requests/ grievances received from promoters against the rejected project proposals in respect of the EoI dated 10.03.2018 issued under the Scheme for Integrated Cold Chain and Value Addition Infrastructure. Technical Committee (TC) was directed to re-consider these proposals before placing the same before IMAC. Accordingly, these proposals were considered by TC on 05.11.2019. IMAC was further informed that two additional agenda proposals in respect of M/s Golden Hatcheries, Karnataka and M/s Vallhabha Milk Products Pvt. Ltd., Tamilnadu considered by TC in its meeting held on 11.12.2019 are also being placed before IMAC for consideration.

4. The IMAC discussed and deliberated each agenda item. Following decisions were taken: -

Agenda Item No. 1: IMAC decision sought on proposal of M/s. Aimjay Agro Fresh LLP, Navi Mumbai, Maharashtra for approval.

IMAC reconsidered the agenda and after discussion with the promoter reiterated its earlier decision to consider the proposal as ineligible.

Agenda Item No. 2: IMAC decision sought on proposal of M/s NGK Trading Company Pvt Ltd, Navi Mumbai, Maharashtra for approval.

IMAC reconsidered the agenda and after discussion with the promoter reiterated its earlier decision to consider the proposal as ineligible.

Agenda Item No. 3: IMAC decision sought on proposal of M/s JKC General Trading Company, Navi Mumbai, Maharashtra for approval.

IMAC reconsidered the agenda and after discussion with the promoter reiterated its earlier decision to consider the proposal as ineligible.

Agenda Item No. 4: IMAC decision sought on proposal of M/s Puthuparambil Agencies Pvt Ltd, Kottayam, Kerala for approval.



Promoter has not attended the meeting. However, IMAC considered the agenda and after detailed deliberations decided to reject the proposal since the applicant was not meeting the minimum score required to be eligible. IMAC further advised that in case applicant is interested in reapplying under the next phase of EOI pertaining to ICC scheme, no "Earnest Money Deposit (EMD)" would be charged from the applicant.

Agenda Item No. 5: IMAC decision sought on proposal of M/s CRPL Infra Pvt Ltd, Howrah, West Bengal for approval.

IMAC considered the agenda and after detailed deliberations rejected the proposal since applicant had not envisaged separate Technical Civil Work distinct from the existing facility as per clause no 8(n) of Scheme Guidelines dated 08.03.2019, which states that "*Expansion projects will be supported provided separate Technical Civil Work and Plant & Machinery are envisaged, distinct from the existing facility*".

Agenda Item No. 6: Request of the promoter for re-calculation of grant-in-aid and change in location of the project for M/s Golden Hatcheries, Tumkur District, Karnataka.

IMAC noted the request of the promoter and accepted the recommendation of TC for revision of eligible project cost from Rs. 1423.25 lakh to Rs. 1512.13 lakh and revision of eligible grant from Rs. 635.23 lakh to Rs. 679.67 lakh in respect of the cold chain project, M/s Golden Hatcheries.

Further, IMAC approved the request of the promoter for change in farm level infrastructure cum processing centre location of the project from Survey No. 47/1, 47/2, 284/1, 284/2, Seebi Agrahara Village, Kallambela Hobli, Sira Taluk, Tumkur District, Karnataka to Sy. No. 109, Dyagera Halli village, Gowdagere Hobli, Sira Taluk, Tumkur, Karnataka.

Agenda Item No. 7: Request of M/s Vallhabha Milk Products Pvt Ltd, Yadadri Bhuvanagiri, Telangana for revision in grant.

IMAC considered the agenda and after detailed deliberations, approved Technical Committee recommendation of downward revision in grant from Rs. 788.09 lakh to Rs. 670.74 lakh and eligible project cost from Rs. 1829.17 lakh to Rs. 1460.91 lakh.
