IMPORTANT NOTICE

Subject: Submission of the documents in support of their Net worth certificate regarding EOI / proposals for setting up Mega Food Parks-reg.

The undersigned is directed to refer to your proposal submitted in response to Ministry's EOI notice dated 10.02.2014 inviting EOIs for setting up Mega Food Parks under this Ministry's Scheme of Mega Food Parks and requested to furnish the following documents in support of networth of the individual promoters:

- 1) In case of land forming part of the networth, the ownership documents, duly authenticated by the concerned District Collector may be furnished. The valuation of the immovable assets on the basis of circle rates declared by the concerned State Government should be duly certified by the concerned District Collector.
- 2) In case of investment in shares of the listed companies, proofs of the market value of the share at the time of calculation of the value of the investment may be furnished.
- 3) In case of investment in unlisted companies, the latest audited balance sheet duly certified by the Statutory Auditors may be furnished to calculate the value of shares in that company.
- 4) The miscellaneous assets should be clearly specified and basis of calculation of their value, duly certified by the concerned Govt. approved valuer may be furnished.

2. All the applicants are requested to furnish the above information within two weeks from the date of issue of this letter. Any information received after the period of two weeks will not be accepted by the Ministry and the proposal may become ineligible on account of not furnishing the above supporting documents in support of the networth declared by the individual promoters in the SPV in the EOI proposals.
