Out of 75 eligible proposals received against Expression of Interest (EOI) dated 07.05.2012, 31 proposals were not complete in terms of documentation and could not be considered for final approval in Approval Committee (AC) meeting held on 23.08.2013. It has been observed that required documents are still pending from some of these applicants.
